Judge Allocation System (JAS)

- The maximum number of FISM Official Judges is set at 150.
- The method to assign the maximum number of judges to each country is derived from the CAS (Contest Allocation System).
 - ✓ The number of FISM Official Judges for a continental FISM division should be calculated as the proportion of its collected number of votes to the total number of votes in the General Assembly of the FISM.
 - ✓ The main advantage of the system is that it uses an objective criterion (membership).



JAS main rules

- The maximum number of FISM Official Judges for continental divisions and countries is recalculated every 3 years.
 - Every continental division may have at least 4 judges to make it easier to organize a FQC (FISM Qualified Contest) on every continent, with judges from the same continent.
 - ✓ Every country has the right to have at least 1 judge.
 - ✓ A country can apply for a FISM Official Judge position ONLY if there are free slots filled by the JAS rules.
 - ✓ If the calculation with JAS (every 3 years) diminishes the number of FISM Official Judges for a country that has all the slots occupied, all the appointed judges will remain FISM Official Judges, but no new applications will be allowed.



Transition period

- All FISM Official Judges at the time of the application of JQS 2.0 will remain FISM Official Judges.
 - ✓ If at the time of the application of JQS 2.0 a country has a number of FISM Official Judges higher than the number calculated with JAS, it will stay with that number, yet when a FISM Official Judge of that specific country is no longer a judge (e.g. passes away, her/his association is no longer a member of FISM, resigns, etc.), she/he will not be replaced.
 - ✓ All the judges in training during the transition period can continue the qualification procedure.
 - ✓ All the applications during the transition period will be handled by the FISM Board case by case in favour of Magic and FISM.

Becoming a FISM Official Judge



Prerequisites

- The judge has to be qualified in the Art of Magic and in judging magical performances.
- There is no discrimination for age, gender and cultural background.
- The judge should be able to communicate in English.
- The judge should ensure continuity and availability to be part of a FISM jury panel.



Prerequisites

- The candidate has to be sponsored by the President of her/his association (FISM member) and by a FISM Official Judge.
- Applications can be submitted at any time during the year; they will be examined by the FISM Board from October 1st to December 31st of each year.
- The candidate has to accept and sign the NdA and the rules that apply to FISM Official Judges.
- The candidate has to be of high moral and ethical character.



Training and evaluation procedure

- A candidate can become a FISM Official Judge only:
 - ✓ if she/he has passed the 5 tests online (with 4 evaluations consistent* with the average of the scores given by FISM Official Judges);
 - ✓ if she/he has participated as a jury member in training in 3 FISM Qualified Contests live where the FISM OSS** is used, and if her/his scores have been consistent* with the average of the scores given by FISM Official Judges of the jury panel at least for 2 times in a row.
 - ✓ If a candidate does not ask to receive a test online or does not participate in an FQC for 3 years in a row, she/he must start the procedure from the beginning.

FISM Official Judge duties

A FISM Official Judge must:

- ✓ inform the FISM board (before or after the event) when and where she/he has been a member of a jury panel during a FQC competition (FISM Qualified Contest).
- ✓ If the FISM Official Judge is the President of the jury panel during a FQC, she/he will be responsible for applying all the procedures of the FQC jury.
- ✓ The FISM Official Judge must ensure the continuity and her/his availability to be part of a FISM jury panel when appointed in a jury panel, pay attention to her/his continuous training and attend as many FQCs as possible to keep up to date with the new trends, skills and techniques of the contestants.



FISM Official Judge appointment

- A FISM judge in training will be appointed as FISM
 Official Judge after achieving positively her/his training
 and evaluation procedure and getting the approval of the
 FISM International Board.
- She/he will be handed her/his FISM Official Judge card during a FISM Qualified Contest in an official ceremony.



FISM Board rights and duties

- According to the FISM Contest Rules and Procedures (art. 2 b), the judges for the FISM WCM jury panel are chosen by the FISM Board of Directors.
- In instances where the application of the above does not allow for a timely constitution of a FISM jury, the FISM Board will use its best judgment to break the impasse.
